

# <u>Travel and Tourism</u> Component 3 – Influence on Global Travel & Tourism Essential Content A



# How does this unit link to prior learning?

In this exam component you will build on the knowledge, understanding and practices acquired and developed in Components 1 and 2. Using your knowledge from component 1 of the major components of the travel Industry in the UK and applying this knowledge and understanding to the global travel and tourism market. You will apply the knowledge built of customer needs in component 2 to understand how governments manage and develop tourism to meet the demands of both the customers and the local communities.

#### What will you be learning about?

You will learn about and understand the positive and negative influences of different factors on global travel and tourism, and how these factors can affect global tourist destinations and travel and tourism organisations. They will also learn about the factors that influence visitors and how these may affect their choice of destination. You learn about the types of organisation that may respond to different factors and the ways in which they may respond. You will learn about how these factors relate to specific contexts, including organisations, visitors and destinations. You will also learn how to interpret data and graphical information in relation to these factors.

# Key Focus

The key focus of this unit of work is to understand the positive and negative influences of different factors on global travel and tourism. You will cover the following key areas A1 – Factors influencing global travel and tourism

A2 - Response to factors

# We will develop our learning by studying the following sequence of lessons:

- Factors influencing global travel and tourism Economic factors (A1)
   You will learn about how recessions, employment levels, cost and other factors impact on the industry.
- 2. Factors influencing global travel and tourism Political factors (A1)
  You will learn about different legislations and reasons behind these for the industry and the impact political stability /instability can have on the industry.
- 3. Factors influencing global travel and tourism Natural factors (A1)
  You will learn how sever weather events can create natural disasters as well as the features and physical effects of each.
- 4. Factors influencing global travel and tourism— Media factors (A1)
  You will learn how different types of media are used and how coverage is used in the industry.
- Factors influencing global travel and tourism Safety & Security factors (A1)
   You will learn and understand the risks and safety measures used in the industry and to ensure customer safety.

- 6. Factors influencing global travel and tourism Health Risk factors (A1)
  You will learn about the causes and symptoms of diseases and illnesses and the impact these have on travel and the industry.
- 7. Response to factors Travel & Tourism Organisations
  You will learn about how different organisations respond to certain factors and adapt,
  manage and review their response.
- 8. Response to factors Government
  You will learn about how government organisations on a local, regional and national level respond to certain factors and adapt, manage and review their response.
- 9. Response to factors Voluntary Organisations
  You will learn about how different voluntary organisations respond to certain factors and adapt, manage and review their response.

### Homework guidance:
